⁽a) For Board Participation, no savings calculations have been included due to the unique structure of the financing which, instead of relying on an interest rate subsidy, provides financial savings primarily through a combination of non-level debt service, payment deferrals, and repayment of deferred interest on a simple interest basis.

⁽b) For illustration purposes, all Market Debt Service Comparisons above are based on the individual entities' credit ratings and include costs of issuance. Note that these 2015 savings estimates have been revised to also reflect the actual borrower closing date and additional savings that may be realized, beyond the subsidy, based on the difference between interest rates the individual borrower would have realized in the market (at the time of SWIRFT bond sale) and that of the TWDB's AAA rates.

⁽c) Instead of an interest subsidy, interest on deferred obligation does not accrue for up to 8 years.
